

Demolition Approval Application

This application **must** be submitted **together** with a **Development Application Form**

Before you can demolish any buildings you **must** have Development Approval. If your property is Local or State Heritage listed, is located in a Historic Conservation Zone or contains significant trees, contact the City Development & Safety Department on 8366-4244 for further information.

What information must I include with my Demolition application form?

This form must be completed as part of the application to be submitted for Development Approval for demolition. This form must be attached to a completed Development Application Form and accompanied by two (2) copies of a site plan, together with payment of the associated fees.

The following details must be shown on the accompanying site plan:

- Location and dimensions of all buildings on the site, with the buildings and structures which are to be demolished or retained clearly identified;
- Location of existing trees on the site and if they are to be removed during the demolition; and
- Location of any street trees in or near vicinity of the site.

IMPORTANT NOTES

1. Council's Planning staff can be contacted on 8366 4244 to provide advice on protection and preservation of all trees and must be consulted if any Regulated or Significant Trees are within the vicinity of the site.
2. The *Local Government Act 1999*, Section 235, provides a maximum fine of \$5,000 (or expiation fee of \$315) for any person who, without the Council's authorisation or permit, deposits rubbish, material, or any other substance on a public road or public place.
3. Council will require payment of all costs that arise from damage occurring to Council controlled land (ie. footpaths, verges, kerbing, roadways, street trees etc.).
4. Under the *Environmental Protection Act 1993*, you are reminded of the following hours that are permitted for building work:
 - Construction sites ie. where a licensed contractor is working:
 - 7am to 7pm Monday to Saturday
 - Private work ie. where a homeowner is renovating:
 - 8am to 8pm Monday to Saturday and 9am to 8pm SundayFor more information, contact the EPA on 8204 2004.
5. Under the *Environmental Protection Act 1993* (Burning Policy 1994), the burning of waste material is prohibited. For further information, contact the EPA on 8204 2004.
6. Certain parts of the demolition procedure, for example scaffolding and asbestos removal, require the approval of Safework SA. Contact Safework SA on 8303 0405 for clarification.
7. Pursuant to Section 25 of the *Environmental Protection Act 1993* General Environmental Duty of Care, the Council advises the developer/builder/owner that:
 - Dust should be suppressed on-site to prevent, or at least minimise, air pollution and nuisance to nearby residents.
 - Stormwater or wastewater runoff should be controlled from the building site to prevent and/or minimise, sediment being carried to the water table, road, or stormwater system. Your attention is drawn to the EPA Stormwater Pollution Prevention Code of Practice for the Building & Construction Industry, available from the EPA on 8204 2004.
8. It is recommended that a licenced pest control contractor carry out a vermin eradication program prior to the commencement of the demolition.
9. Construction, building and demolition wastes constitute approximately 50% of waste materials going to landfill in South Australia. Please ensure that your demolition discards are recycled by an accredited reclaimer.
