Named after Admiral Sir John Jellicoe (1859-1935).

Jellicoe was an Admiral during World War I. He was created First Earl of Jellicoe, later becoming Governor-General of New Zealand 1920, and was commemorated by the South Australian Company who owned the land at the time of the subdivision.

John Cleland Drive Beaumont

Origin of present name

Named after John Fullerton Cleland (1821-1901).

John Cleland who was Registrar of Births, Deaths and Marriages lived at the Gleeville property, whose former (pre-subdivision) land John Cleland Drive now runs through. His sister Margaret was married to Sir Samuel Davenport of the nearby Beaumont House.

Dr William Lennox Cleland was one of his sons (see Cleland Avenue, Dulwich). A second son, George Fullerton Cleland, one time Chairman of the Burnside District Council, founded the wine firm of G. F. Cleland & Sons.

Gleeville later passed to John's grandson, John Burton Cleland, after whom the Cleland Conservation Park has been named, and one of whose daughters Joan (Paton) was still living in the house in 1998.

Probably named after Joseph Crompton.

Joseph Crompton established the Stonyfell Winery together with Henry Septimus Clark in 1858. Later he married Henry Clark's sister Susan Mary Clark of *Hazelwood* and lived in the nearby *Stonyfell House* which remained in the Crompton family from the 1870s to 1978.

The extension to this road, Woodhouse Crescent is named after one of his sons.

The road was named by the members of the syndicate which developed the subdivision: K.J. Powell, the Trim brothers and Stern Antonis.
